Article 21 is the protection of life and personal liberty i.e. he/she may not be deprived of his life or personal liberty except in the case of laws.

Article 39 make sure about directive principles of state policy.

Article 39(a) ensures that state should secure its men and women equally for their livelihood. Article 39(d) ensures that men and women must be equally paid and no difference in salary must be there.

Article 42 the Constitution consolidate a vital arrangement to assist women. It guides the State to make arrangement for getting simply and compassionate the states of work and for maternity help.

Article 51(A) (e) is related to women. It states that; It shall be the duty of every citizen of India to promote harmony and the spirit of common brotherhood amongst all the people of India transcending religion, linguistic, regional or sectional diversities; to renounce practices derogatory to the dignity of women.

The Kid Marriage Restriction Demonstration of 1929: The act of kid marriage was another social evil from which women in conventional Hindu society endured a great deal. Age at marriage for young ladies was 9 or 10 and subsequent to passing this demonstration the base eligible time of ladies was fixed to 15 years. Later this age was expanded as long as 18 years.

The Hindu Marriage Demonstration of 1955: This Demonstration has perceived the equivalent privileges of people in the issue of marriage and separation. Under the arrangement of this Demonstration either the man or woman can introduce an appeal in a courtroom for separate, spouse has got equivalent option to separate.
